City Council Minutes Regular Meeting January 16, 1980

The City Council met in a regular scheduled Council meeting in the Council Chambers of the Memorial Hall Building at 7:30 O'clock P.M. Mayor Deitrich presided with the following Councilmen present: J. Seip, Van Fleet, Aldrich, Butler, Kerr, H. Seip.

Councilman H. Seip made the motion, seconded by Councilman Van Fleet that the minutes of the regular meeting of January 2, 1980 be approved as presented. Upon roll call the vote was unanimous.

At 7:30 O'clock P.M. Mayor Deitrich announced that the hearing on Revenue Sharing was open for discussion. There were no written or oral objections made.

Jerry Long and Mike Griffin representative from French-Reneker Associates were present. They presented to the City Council the Change Order No. 1 on the 1979 Paving project. A copy of this being made a part of these minutes. Councilman J. Seip made the motion, seconded by Councilman Van Fleet that the Change Order No. 1 be approved as presented, this being miscellaneous changes and items of extra work. Upon roll call the vote was unanimous.

Councilman Butler made the motion, seconded by C uncilman H. Seip that the Change Order No. 2 which is listed as vârious changes and made a part of these minutes be approved as presented by Jerry Long. Upon roll call the vote was unanimous.

Councilman Butler made the motion, seconded by Councilman Van Fleet to approve the estimate on the change Order No. 1, being an increase of \$1,172.56 Upon roll call the vote was unanimous.

Councilman H. Seip made the motion, seconded by Councilman Kerr that the amendment to the Sigourney Municipal Code Chapters 15.04 and 15.12 be approved as read and therefore be passed and approved. Upon roll call the vote was unanimous.

Dick Coffman, Mike Phillips, Marilyn Elliott, Pat Miletich and Keith Epperson, representatived of the Sigourney Ball Inc. were before the Council and asked the Council if they thought it would be possible to get some help to put some new lights and new fencing around the Legion Ball Park. Mayor Deitrich informed this committee that we would resubmit our application for work at the park and ball field but unless we get some help there would not be anything the City coulc do to help them.

Lyle Van Fleet, Chairman of the Water Utility Committee gave the report on the pickups he had checked on for the Water Dept., but these were all 4 wheel drive pickups so they requested he get some prices on just a straight 1/2 ton pickup and have them for the next Council meeting.

Councilman Van Fleet made the motion, seconded by Councilman H. Seip that the Resolution regarding the proposed Involuntary Annexation from the City Development Board be introduced and read. Upon roll call the following voted:

Councilman Van Fleet made the motion, seconded by C uncilman Butler that the 1980-1981 Budget be approved form publication and fixed the vime and place for the public hearing on February 6, 1980 at 7:30 O'clock P.M. Upon roll call the vote was unanimous.
