

CITY COUNCIL MINUTES

February 20, 1980

The City Council met for their regular scheduled Council meeting in the Council Chambers of the Memorial Hall on February 20, 1980 at 7:30 O'clock P.M. Mayor Deitrich presided with the following Councilmen present: Butler, Kerr, H. Seip, J. Seip, Van Fleet, Aldrich.

Councilman H. Seip made the motion, seconded by Councilman Butler that the minutes of the regular meeting February 6, 1980 be approved as presented. Upon roll call the vote was unanimous.

Discussion was held on the water bill for the Keokuk County Jail, and the Deputy Clerk was instructed to average a 2 year period water billing for the jail and from that figure the City might be able to determine some sort of payment for their taking calls for the City Police. This will be brought up at the March 5, 1980 meeting.

Dick Coffman was present from Sigourney Ball Inc. and informed the Council that if they use their name for the lights for the ball field the National Guard will set the poles and do the tower work etc. It was agreed by the Council that this could be done. Councilman Van Fleet made the motion, seconded by Councilman J. Seip that in addition to the \$1000.00 already spent for lights, the City would spend up to \$2500 more for poles and wiring, and limit to \$3500.00. this amount to be taken out of Revenue Sharing Fund. Upon roll call the vote was unanimous.

Councilman H. Seip made the motion, seconded by Councilman Kerr that the warrant issued to the City of Farley, Iowa in the amount of \$1,000. for lights be approved. Upon roll call the vote was unanimous.

Councilman J. Seip made the motion, seconded by Councilman Van Fleet that the Beer license renewal application for Kind's Jack and Jill be approved, as all fees and papers were in order. Upon roll call the vote was unanimous.

Mayor Deitrich brought up the Area XV situation, asked the Council to give them much consideration to a decision as to whether to continue with them, and will be further discussed at the March 5th meeting.

Councilman Butler made the motion, seconded by Councilman Aldrich that the water department schedule change be effective March 1, 1980, with one man working Monday thru Friday and the second man will come in on Tuesday and work thru Saturday plus Sunday, and they will alternate every other week. Upon roll call the vote was unanimous.

Councilman Butler made the motion, seconded by Councilman H. Seip that the hours for Deputy Clerk Marie Tremmel be reduced from 37 1/2 to 34 1/2 hours per week in order that she may take one half day off per week, if the workload or situation is so that the time is available, Upon roll call the vote was unanimous.

Councilman Van Fleet made the motion, seconded by Ron Kerr that the City policy be that the minimum hours worked per week for year round help be 32 hours in order to be considered full time help, and anything under 32 hours work be considered part time. Any changes in working hours to be set by the Council. Upon roll call the vote was unanimous.

Other items discussed were cleaning north side of Memorial Hall, the storm sewer drain on Ringgold St. and alley lights for police car, also office hours for City Clerk's office will remain as they are now, 8:00 A. M. to 4:30 P.M.

There being no further business to come before the Council upon motion, meeting adjourned in form.
