MINUTES OF REGULAR COUNCIL MEETING OF
WEDNESDAY, FEBRUARY 20, 1991

The Sigourney City Council met in regular session in the Council Chambers of the Memorial Hall on Wednesday, February 20, 1991, at 7:30 o'clock P.M., as posted, with Mayor Park presiding, and the following Councilpersons answering roll call: Welter, Wells, Van Fleet, J. Seip, and Butler. (H. Seip was absent.) The City Clerk was also present.

Councilperson Van Fleet moved, seconded by Councilperson Welter, that the agenda be approved as posted. Upon the roll being called, the following voted: Ayes: Welter, Wells, Van Fleet, J. Seip, and Butler. Nays: None. The motion was approved.

Councilperson Wells moved, seconded by Councilperson J. Seip, that the minutes of the regular meeting of February 6, 1991 be approved as submitted. Upon the roll being called, the following voted: Ayes: Welter, Wells, Van Fleet, J. Seip, and Butler. Nays: None. The motion was approved.

Councilperson Butler moved, seconded by Councilperson Wells, that the applications of Kind's Jack & Jill for renewal of their liquor and beer licenses be approved. Upon the roll being called, the following voted: Ayes: Welter, Wells, Van Fleet, J. Seip, and Butler. Nays: None. The motion was approved.

The production well was not drilled when expected because the ground was too soft to move equipment in without creating mud problems. However, Layne-Western will be back as soon as the ground freezes again or dries up enough that their equipment may be taken in easily.

The Mayor advised that F. Lee Hendricks, representing the Sigourney Ministerial Association, asked to use the Memorial Hall auditorium Sunday evening, February 24th, for a prayer service in behalf of our military serving in the Persian Gulf War. He further said he felt that because of the circumstances no charge should be made for such rent. Without voting action, there was no objection on the part of the Council.

The January financial reports of the City Clerk and City Treasurer were before the Mayor and Council and filed. There were some who didn't understand the correlation between the reports and the computer printouts, and the Clerk briefly explained the same.


