## City Council Minutes

## June 18, 1980

The City  $C_{0}$ uncil met in a regular Scheduled Council meeting in the Council Chambers of the Memorial Hall Building June 18, 1980 at 7:30 O'clock P.M. as posted and published. Mayor Deitrich presided with the following Councilmen present: Van Fleet, Aldrich, Butler, Kerr, H. Seip, J. Seip.

Councilman H. Seip made the motion, seconded by Councilman Van Fleet that the minutes of the regular meeting held June 4, 1980 be approved as presented. Upon roll call the vote was unanimous.

Councilman H. Seip made the motion, seconded by Councilman Van Fleet that the minutes of the Special meeting of June 11, 1980 be approved as presented. Upon roll call the vote was unanimous.

Councilman Van Fleet made the motion, seconded by Councilman Kerr that the following Cigarette license renewals be approved for the ensuing year, Blackies Super Valu, Greene Oil Co. Lauretta Schultz dba Clubby's Incc, Kind; s Inc. dba Kind; s Jack and Jill, Cooke Drugs, Mr. Z's Lounge, Town House Cafe, Kassebaum Corp. dba Casey's General Store, Maid-Rite, Sigourney Oil Inc., The Clubb House, Jacobs Implement, Super Go Inc. Upon roll call the vote was unanimous.

Councilman Butler made the motion, seconded by Councilman H. Seip that a warrant for \$800.00 be issued from Revenue Sharing to the Sigourney Ball Inc. for the Legion Ball Field improvements. Upon roll call the vote was unanimous.

The Council agreed that the Street Supt. be notified to block off the 3 sides of the square for Krazy Days to be held July 19, 1980.

Councilman Van Fleet made the motion, seconded by Councilman Kerr that Michael Phillips electrical license be approved as the necessary bond was all in order. Upon roll call the vote was unanimous.

Councilman H. Seip made the motion, seconded by Councilman Van Fleet that the resolution establishing a stop sign at the intersection of West Walnut Street and West Street in the City of Sigourney, Keokuk County, Iowa be approved. Upon roll call the vote was unanimous.

Councilman J. Seip made the motion, seconded by Councilman Van Fleet that the Resolution accepting Fred Carlson Company, Inc., of Decorah, Iowa in the amount of \$524,423.40 for the construction of the 1980 Street Improvement Program be approved. Upon roll call the vote was unanimous. A Copy of this resolution being made a part of these minutes.

Other business discussed at the Council meeting but no decision reached at this time are as follows:

Leo Wallerich was before the Council and asked about the opening of the West end of West Elm street, the Council decided nothing would be done on this unless the lots were developed or a new home was to be constructed on these lots.
