REGULAR COUNCIL MINUTES

June 18, 1986

The City Council met for their regular scheduled Council meeting in the Council Chambers of the Memorial Hall on June 18, 1986, at 7:30 O'clock P.M. as posted and published. Mayor Deitrich presided with the following Councilmen answering roll call: Butler, Kerr, H. Seip, J. Seip, Park and Clawson.

Councilman H. Seip made the motion, seconded by Councilman Park that the minutes of June 4, 1986 be approved as presented. Upon roll call the following voted:

Deputy City Clerk and Treasurers financial statements were presented.

Terry Greenley and Dick deRegnier, representatives from the Sigourney Area Development Corporation were present at the meeting with an update of the EDA project, and to discuss with the Mayor and City Council the concept of building a new community building which will be used for the Library, fire station, City Clerk's office and Veterans Community rooms. Greenley explained the cost per entity and was at the meeting also to find out if the City of Sigourney would be interested in this project.

Councilman H. Seip made the motion, seconded by Councilman Clawson that Peggy Kleinschmidt be appointed City Clerk, and her decision to accept the position to be made by June 24, 1986. Upon roll call the following voted:

Discussion was held on the burning of the old house belonging to Waglers, which has been torn down, and the decision of the Council made earlier to move it across the road and burn, still stands.
