The City Council met in a regular scheduled meeting in the Council Chambers of the Memorial Hall Building as posted and published. This meeting being held August 21, 1985 at 7:30 O'clock P.M. Mayor Deitrich presided with the following Councilmen answering roll call: Butler, Kerr, H. Seip, J. Seip, Garringer, Aldrich.

Councilman Garringer made the motion, seconded by Councilman Butler that the minutes of the regular meeting of August 7, 1985 be approved as presented. Upon roll call the vote was unanimous.

Councilman H. Seip made the motion, seconded by Councilman Kerr that the resolution for Road Use Tax be approved. Upon roll call the vote was unanimous.

RESOLUTION

WHEREAS, Highway 149 was designed and constructed in the early 1930's and for over 50 years has served the people and towns along its route as a connection to markets for products and to supply vital needs.

AND WHEREAS, in these past 50 years, the route of Highway 149 has had no major changes or improvements, from Parnell--south during the past 50 years despite the increase in truck size and useage.

AND WHEREAS, with the loss of railroads we extensively rely on the truck traffic for the industrial and agricultural development and general well being of this section of Iowa.

AND WHEREAS, if we are to survive, we must have a safe and reasonable route to market our products; we must help our present industries market their products by a quick, efficient and safe route; we must have a reliable road system to attract new industry to our area, to provide jobs for our available labor market.

NOW THEREFORE BE IT RESOLVED by the council of the City of Sigourney, Iowa, that in connection of the recent redesignation of U.S. Highway 151 (from Highway 149) north of Interstate 80, that the Iowa Department of Transportation redesignate as U.S. Highway 151 all of the current Highway 149 system thus extending the existing U.S. Highway 151 from its present terminus at Interstate 80, Exit 225, to a route along Interstate 80 for four miles to the Williamsburg junction, then south along Highway 149 to its present terminus, just north of Ottumwa.


BE IT FURTHER RESOLVED that the City Clerk of Sigourney is directed to mail a copy of this Resolution to the Iowa Department of Transportation.

BE IT FURTHER RESOLVED that the City of Sigourney join the "Highway 151 Association."

The above Resolution having been duly considered and unanimously passed by the Council for the City of Sigourney, Iowa on the 4th day of September, 1985, is hereby approved by the undersigned Mayor for the City of Sigourney, Iowa.

PUBLIC NOTICE
AFFIRMATIVE FAIR HOUSING POLICY

This notice is published pursuant to the requirements of Executive Order 11063 on equal opportunity in housing and non-discrimination in the sale or rental of housing built with Federal assistance, and with Title VIII of the Civil Rights of 1968, as amended, which prohibits discrimination in the provision of housing because of race, color, religion, sex or national origin.

City of Sigourney, Sigourney, Iowa advises the public that it will administer its assisted programs and activities relating to housing and community development in a manner to affirmatively further fair housing and it shall also take action to affirmatively further fair housing in the sale or rental of housing, the financing of housing and the provision of brokerage services.
